**Qualifications/Experience:** Registered Psychologist/Registered Clinical Social Worker/Master's in Counselling with experience working with children, youth and adults who have experienced past trauma, including but not limited to mental illness, substance addiction, sexualized behaviours, sexual trauma and FASD.

**Other Requirements:** A current, clear Police Information Check (vulnerable sector included) and Child Intervention Record Check (within the last 6 months), current registration with professional body, current liability insurance and professional references. The successful candidate must have the ability to travel to Edmonton, Stony Plain, Wetaskiwin, and Ponoka.
